Application Guidelines for Participating Organizations

We have held the Nagasaki International Festival since 1999 to promote globalization within local communities and expand grass-roots international exchange with the help of organizations engaged in international cooperation and exchange. This year will mark the 28th festival. We look forward to an enjoyable day for local people and people of all nationalities living in Nagasaki. We hope that the event will increase our understanding of international cooperation, international exchange and multicultural society, thereby leads to the vibrancy of our prefecture.

Event Outline

Time: 11:00 AM to 4:00 PM, Sun. 13th December 2026

Location: 1st floor, Nagasaki Prefectural Government Bldg. (3-1 Onoue-machi, Nagasaki City)

Participating Organizations Must Fulfill the Following Criteria:

- Be an organization that is engaged in international cooperation or exchange, or a (Japanese) supervising organization/company that promotes such international activities.
- However, supervising organizations/companies must exhibit together with foreign residents related to their organization/company.
- Also, if an institution engaged in international cooperation or exchange as a part of its business is deemed to be exhibiting as an extension of business activities, it will not be eligible to participate.
- Be based in Nagasaki Prefecture, and carry out activities mostly or entirely within the prefecture.
- Have a clearly-designated responsible person who is able to be contacted during the day.
- Agree to allow the NIA to use photos taken during the event for promotional purposes such as PR magazines and/or posters.

Ways to Participate

Ways for your organization to participate include but are not limited to: exhibition booths (i.e., a display about the organization's activities); flea markets; booths selling fair trade goods & handicrafts from overseas, cooked food made with fair trade ingredients, items produced through a collaboration between Japanese and foreign workers; 'try-out' corners (i.e., trying on traditional clothing); bazaar; and so on.

Number of Organizations

We will limit the number of participating organizations to about 30. If a large number of organizations apply, we will hold a drawing to decide which organizations will participate.

Participation Fee

Participation is free of charge.
